Abstract:- Logistics is the support function of an organization and it means having the right object, at the right place, in the right time, Logistic management involves planning, organizing, leading, coordinating and controlling the logistic activities of an organization. In military science, maintaining one's supply lines while disrupting those of the enemy is a crucial element of military strategy, since an armed force without resources and transportation is defenceless. Logistics is the management of the flow of goods and services between the point of origin and the point of consumption in order to meet the requirements of customers. Logistics involves the integration of information, transportation, inventory, warehousing, material handling, and packaging, and occasionally security. Logistics is a channel of the supply chain which adds the value of time and place utility. Today the complexity of production logistics can be modelled, analyzed, visualized and optimized by plant simulation software. The logistics of physical items usually involves the integration of information flow, material handling, production, packaging, inventory, transportation, warehousing, and often security. Military logistics was already practiced in the ancient world and as modern military have a significant need for logistics solutions, advanced implementations have been developed. In military logistics, logistics officers manage how and when to move resources to the places they are needed.

Logistics management is the part of supply chain management that plans, implements, and controls the efficient, effective forward, and reverse flow and storage of goods, services, and related information between the point of origin and the point of consumption in order to meet customer's requirements. The complexity of logistics can be modelled, analyzed, visualized, and optimized by dedicated simulation software. The minimization of the use of resources is a common motivation in all logistics fields. A professional working in the field of logistics management is called a logistician.

A motor carrier transports passengers or property for compensation. A broker is a person or an entity which arranges for the transportation of a property by a motor carrier for compensation. A broker does not transport the property and does not assume responsibility for the property. A freight forwarder is a person or entity which holds itself out to the general public to provide transportation of property for compensation and in the ordinary course of its business. It assembles and consolidates or provide for assembling and consolidating, shipments and performs break-bulk and distribution operations of the shipments.

It assumes responsibility for the transportation from the place or receipt to the place of destination. A company can take a brokerage if it is a mediocre company between two transport. The drivers are on contract bases in logistic companies and owner operates the drivers. The Aadhar ID and passport size photograph of drivers are mandatory and has to



be with the operator otherwise they are move to court. In companies drivers have a separate restrooms to take rest.

They are provided food and facilitations by a company itself. Drivers are asked to have relationships with the suppliers or brokers because they transport the shipment and take money from the other brokers. Relationships are maintained through mails, calls and messages etc. Regular mails of receipts are forwarded to different brokers where the shipments have to be dispatched. One receipt is given to the driver so the record of shipments is in his hands.

Timely payments are given after the shipment is dispatched by customers and money is brought by the drivers to the initial company or broker who send the shipment insurance of all motor vehicles are done who all are involved in shipments. Today the operations are done through app named boss where all toll taxes are paid online and insurance is done online. Fuel cards are presented and payment of that is done online. There are various cash backs which one receives on toll taxes and fuel cards.

GPS tracking system is also present in the app and in truck and are interconnected. Medical facilities to drivers are provided by the motor vehicle operator. Lubricants are also important and are timely given to motor vehicle so that they operate efficiently. Safety is in the hands of driver who operates the vehicle. The labourers are present in the company who ship the shipments from go down to trucks or any other motor vehicle and vice versa. Income tax is paid by this company every year. This company was started in 1971 by Manak Chand Jain and now the sole proprietor Shri Subhash Chand Jain.

His two sons Shri Subodh Kumar Jain and Shri Sukesh Kumar Jain also works in the same company and are proprietor there. Here 8-10 people as staff works and its branches are present in Udaipur and Bhilwara and in Udaipur operates as Kota Udaipur Transport Company and is owned by cousins Shri Nitin Jain and Shri Sanjay Jain and in Bhilwara operates as Kota Bhilwara Transport Company and is handled by staff there. There are 10-20 labourers working in Jain Goods Transport Company Kota. This company will complete its 50 years in 2021 and all proprietors are very hardworking in this company.

- H1: There is a satisfaction between customers, labourers and workers.


2.2 Sampling



3. QUESTIONNAIRE FOR CUSTOMERS


- Q1. Are you satisfied with the transport Bilty charges charged by transport?

- Q5. Are you satisfied with the quality that transport gives to you?













3.1 For Labour

- Q5. Are you satisfied with the other colleagues at the transport?






3.2 For Workers
